Economic development is underway in Jackson Township, where there are approximately 2,200 businesses. Mercy Medical Center Opens New Health Center and STATCARE

Mercy Medical Center celebrated the opening of the new Mercy Health Center and STATCARE of Jackson in November. A formal dedication, blessing and ceremonial ribbon cutting were held, followed by a public open house.

The New Mercy Health Center will serve the residents of Jackson Township, Massillon and Western Stark County. The Health Center includes a STATCARE Immediate Care Center, imaging center, laboratory services, Mercy Heart Center cardiac diagnostic services, and a sleep lab. Offices for Tri-County Hematology and Oncology have also moved to the building. A *Mercy Primary Care* physician office and Urology One offices will open in early 2012. The new facility will provide over 100 jobs, with more to be added in the future.

Located next to the Paul and Carol David YMCA near the corner of Wales Avenue and Fulton Drive in Jackson Township, the 55,000 square-foot health care facility represents a unique partnership and will meet the health care needs of the community in a variety of ways.

“At our groundbreaking last year, I referred to this land as a ‘field of dreams,’” said Thomas E. Cecconi, Mercy President and CEO. “Today I feel great pride in the transformation of this ‘field of dreams.’ The community had a vision and we are proud to be a part of it.”

Jackson Township Fire Department News

"First and foremost I want to take a moment to wish your family a safe and happy holiday season. It is hard to believe summer and fall have passed and we are again in the winter season. With this season comes some special fire safety concerns due to the cold weather when our families

become confined to the indoors more than any other time of year. Take time to review these safety concerns with the occupants in your home to insure your holidays are not ruined by an unforeseen incident:"

- Stay in the kitchen when you are frying, grilling or broiling food. If you must leave, even for a short time, turn off the stove.
- Keep fixed and portable space heaters at least three feet from anything that can burn.

- Turn off heaters when you leave the room or go to sleep.
- Ask smokers to smoke outside. Have sturdy, deep ashtrays for smokers.
- Keep matches and lighters up high, out of the reach of children, preferably in a cabinet with a child lock.
- Replace electric cords that are cracked, damaged, have broken plugs, or loose connections.
- Keep candles at least one foot from anything that can burn. Blow out candles when you leave the room or go to sleep.
- Make a home fire escape plan and practice it at least twice a year.
- Install smoke alarms on every level of your home, inside bedrooms, and outside sleeping areas. Interconnect smoke alarms throughout the home. When one sounds, they all sound.
- Test smoke alarms at least once a month and replace conventional batteries once a year or when the alarm "chirps" to tell you the battery is low. Replace any smoke alarm that is more than 10 years old.
- If you are building or remodeling your home, install residential fire sprinklers. Sprinklers can contain and may even extinguish a fire in less time than it would take the fire department to arrive.

Dry-Hydrants

The steady growth of Jackson Township has brought with it the installation and extension of water lines throughout the Jackson Township community, which the fire department depends upon as the primary source for extinguishing fires. Yet, there are areas within Jackson Township that do not have a dedicated water source and the fire department must rely on other methods that supply water to fires that occur in these areas. One method the fire department utilizes to supply water at a fire scene are tanker trucks. Tankers, as they are more commonly referred, carry on average 3,000 gallons of water. Combined with the water carried by fire engines, the Tanker's large volume of water ensures that the fire department has a sufficient supply of water to extinguish fires in non-hydrant areas.



A second method for supplying water at a fire scene is a *dry-hydrant*. The fire department utilizes *dry-hydrants* as an alternative to supply water at a fire scene. *Dry-hydrants* are permanent non-pressurized water sources located near large volumes of water such as ponds and lakes. There are several *dry-hydrants* located in Jackson Township, one of which is located in Jackson's North Park. Typically, *dry-hydrants* are installed by private landowners. Because the fire department relies on *dry-hydrants*, flow tests are performed to measure the volume of water they will supply during a fire. In some cases, pond sediment or broken plumbing will prevent a *dry-hydrant* from supplying the appropriate volume of water necessary to extinguish a fire. These instances require the *dry-hydrant* to be either serviced or repaired to ensure it is functional in the event it is needed during a fire. During the months of August-October, Fire Department personnel worked with landowners in a collaborative effort to repair two *dry-hydrants*, one of which was relocated to improve accessibility for fire department vehicles. The repairs and subsequent relocation will allow the fire department to continue utilizing alternative water supply methods in areas where standard fire hydrants do not exist.

Both events had a huge attendance and are examples of why Jackson Township is such a great place to live, work, play and to raise a family.

SAFE SHOPPING TIPS

DURING THIS BUSY HOLIDAY SEASON, PLEASE KEEP THE FOLLOWING SAFE SHOPPING TIPS IN MIND:

- Even though you are rushed and thinking about a thousand things, stay alert to your surroundings and the people around you.
- Shop before dark if possible. Coordinate shopping trips with a friend if you plan to be out late.
- Park in a well-lighted area. Don't walk to your car alone if it's parked in a dark area. (Several stores and the Mall have escorts/security who can assist you to your vehicle)
- Lock your car and close your windows, even if you are only going to be gone for a few minutes. Lock your packages and valuables in the trunk. Have your key in hand prior to arriving at your vehicle.
- Wait for public transportation or rides from friends in busy, well-lighted areas.
- Teach your children to go to a store clerk and ask for help if you become separated when shopping. Tell your children never to go into the parking lot alone.
- Avoid carrying large amounts of cash and don't carry it all in one place. Pay for your purchases with a check or credit card when possible.
- Be extra careful with purses and wallets. Carry your purse tightly under your arm and don't leave it unattended, even for a minute.
- Try to pre-plan your route. If you can limit left hand turns in the Belden Village area to those intersections or driveways that have a traffic signal you'll be doing yourself and other motorists a huge favor.



CAR DRIVING TIPS FOR WINTER SAFETY

These car-driving tips can help you navigate the snowy and icy conditions of winter safely. It is essential for parents to share these tips with teens. Most young drivers learn how to drive during the warm months, which teaches nothing about the hazards of black ice and snowdrifts. However, your kids need to learn how to handle a car in snowy conditions.

It is a good idea for parents to ride along with teens the first few times they venture out in treacherous weather. You can also look for defensive driving quizzes online. For the greatest measure of safety, sign up your teen for a defensive driving course. These classes go far beyond what's taught in most driving schools, giving students hands-on opportunities to practice controlled braking or reacting to a spinout.

Here are some tips for safe driving in the winter.

1. Slow down. Drive at least 10 mph slower than you usually would if roads were fairly clear. Patches of ice can be hidden and surprise you. Slower speeds help you stay in control.
2. Give space. Cars around you may start to skid. Maintain at least three car lengths of distance between you and the car in front of you, which gives you more time to respond. Remember, even if you're prepared, other drivers might not be.
3. Brake slowly. Slamming on the breaks is a sure way to skid and lose control. Ease your foot off the brake if you begin skidding.
4. If the roads are very snowy, put your car in low gear and take it slow. Avoid cruise control and overdrive.
5. Check your wiper fluid. Make sure it is made for cold weather, and is fully stocked. Salt buildup on your windshield can drastically reduce visibility.
6. Beware of ice. Bridges and overpasses freeze before the road does. Slow down when crossing them and when using on and off ramps.
7. Don't pass plows and salt trucks. You're safer behind them and you'll get a windshield full of salt if you try to pass.
8. Adjust your driving to meet the conditions. Remember that the response time of your vehicle to stops and starts is reduced when snow is on the road.
9. Spinning your wheels digs you in deeper if you're stuck in the snow. Try rocking back and forth by switching between forward and reverse. Keep some salt, sand or kitty litter in the car, as well as a shovel, to clear away snow. Use a light touch on the gas. If the wheels start to spin, stop and dig the car out a little more. Spinning your tires creates ice ruts that will keep you trapped.
10. Steer into a skid. If your car starts to skid, steer in the direction of the skid. Slow down gently, rather than slamming on the brakes. Newer cars have antilock brakes that reduce the risk of skids, but these won't cut down on your stopping distance or help your car stop if you're on an icy grade.

SIGN UP FOR EMERGENCY ALERTS & ADVISORIES

Stay informed by signing up for emergency alerts advising you of road closures and other significant alerts from your Jackson Township Police Department. It is very simple to do.

We have a great new service available for you to receive community alerts. It is

called Nixle, and if you are interested in receiving alerts, please register through the Nixle website (<http://www.nixle.com/>). It immediately connects you to trusted, important information by text message, email, and over the web. By registering, you get Jackson Township Police Department emergency alerts and advisories.

(NOTE: After selecting the Nixle link, you may register by entering your zip code in the field provided and clicking Go! On the next screen you will see a Sign Up Now box.)

POLICE DEPARTMENT QUESTIONS & ANSWERS

First, I am happy to report that we saw very few incidents of vandalism or criminal damaging this past Halloween. I was contacted by a resident residing in Hampton Hills allotment concerning trick-or-treat. She asked if allotments report to the police department when they may be deviating from the regularly scheduled trick-or-treat times. The time that we designate is actually recommended by our Stark County Commissioners. The Board of Trustees follow suit and adopt the times at a Trustees' meeting. I shared this with the caller and she said that her particular allotment held theirs at a different time.

There is no formal mechanism in place regarding the notification of the Township or the notification of other residents living in the affected area. There are a few allotments that have associations that wish to hold their festivities at a later time and communicate that to the residents of that allotment. The police department does like to know if your allotment is having your trick-or-treat at a different time. We add patrols so officers and our youth explorers can distribute candy to our children, helping us ensure the experience is safe and enjoyable. It seems we get an influx of non-residents when there are different times. I would keep this in mind when making the decision to adjust your times, deviating from the recognized times.

Secondly, I was approached about the township's recently adopted refuse resolution. What is it? The Board of Trustees recently adopted a resolution restricting the hours of when trash can be collected within 500 feet of any residential dwelling, apartment building or other residential structure. The hours of collection are restricted to between 6:00 a.m. and 8:00 p.m. Our officers have been instructed to enforce the resolution, resulting in the offender subjecting themselves to a \$500 fine for a first offense and \$1,000 for any future violations.



PARK SHELTER APPLICATION PROCESS

Beginning Tuesday, January 3, 2012, you can turn in your shelter application forms to reserve any of the four Jackson Township Parks shelters. Reservations will not be taken over the phone. The reservations are taken on a first-come, first-served basis. Once your applica-

tion is received, your date and time will be held. You must pick up your permit approximately one week prior to your reservation date. For shelter availability, contact the Jackson Township Park office at 330-832-2845.

If you are a resident or business owner in Jackson Township there is no charge to use the shelters. For non-residents there is a \$10 per hour charge.

JACKSON TOWNSHIP PARK HOURS

Starting December 1, 2011 through February 28, 2012 the North Park is open from sunrise until 8:00 p.m.

South Park, Crystal Springs Bridge Park, Edward & Mary Zink Park, Joseph E. Fisher Park, Nelson M. Keck Park, Strausser Elementary Park, and Stuhldreher Street Fields are open one-half hour before sunrise to one-half hour after sunset.

Pets are permitted in all of our parks except the North Park. While on any other park grounds, lots, streets, drives or any other park facilities, all pets shall be controlled by a leash connected with a person or fixed object. Do not leave pets unattended and please remember to clean up after your pet.

STORM SEWER: Arlington Ave. was closed between Mudbrook and Fulton in early July to install 36" diameter storm piping to serve the Carrington allotment on the west side and the new Greenwich Place allotment being built on the east side of Arlington. The pipe further serves to prevent flooding in the older original Jackson Bluffs and Jackson Meadows allotments on the east side of Arlington. The project was completed in time for school opening and opened the door for resurfacing of Arlington from Fulton to Mount Pleasant.

RESURFACING: The resurfacing of 13 miles of Township roadway was completed by a publicly bid contract. 1.5 miles required grinding prior to the new surface, and curb edge preparation was accomplished on 4.7 miles prior to resurfacing.

STRIPING: Forty miles of the busier Jackson Township roads were restriped with centerlines, edge lines, stop bars, and arrows for your driving assistance and safety.

CURBING: The curbing contract in 2011 completed replacement of 8,400 feet of deteriorated curbing. Mother nature continually requires upkeep of our infrastructure.

CLEAN WATER EFFORTS: The Highway Department continuously collects road sweepings, catch basin cleanings, and debris from Jackson roadways. The Federal Clean Water Act requires that this contaminated material be kept dry from rain and snow to prevent the creation of leachate. A large roof shelter has been constructed at the Jackson Township Highway Garage to accomplish this need.



Construction For 2012

FRANK AVENUE

Widening and improvement of Frank Avenue commenced work in the fall of 2011 and will be completed in 2012. This joint project with the Stark County Engineer will add a northbound lane from Mega to an improved intersection at Portage, tapering back to two lanes at Bob O'Link. Further construction will continue north on Frank Avenue as completed design, right-of-way, and OPWC grant funding becomes available.

HILLS & DALES ROAD

Widening and improvement, including a large storm sewer, will be publicly bid by the Stark County Engineer in the spring of 2012. This joint project from the west side of Woodlawn-Dressler to Whipple will clear up long standing drainage problems and improve traffic in this highly developed section of Hills & Dales.

JACKSON TOWNSHIP CONTRACTS

Jackson will continue improvement and maintenance of Township infrastructure by publicly bidding and contracting resurfacing, curb replacement, striping, and drainage projects in 2012. Daily repair and maintenance of signage, surface, and drainage problems will be completed in-house by the Highway Department.



WINTER IS BEARING DOWN ON OUR ROADWAYS AND YOUR TRAVELS

Jackson Township has carefully prepared our trucks, truck drivers, and salt material to respond and maintain safe road surfaces for our residents, school, and business travel operations. Winter presents variations of ice, snow, more snow and drifting snow, along with high and low temperatures and winds, light and dark working conditions all arriving to challenge our efforts. Your Jackson Township Public Works Department is ready 24 hours a day and 7 days a week.

FINANCIAL CHALLENGES FOR THE PUBLIC WORKS DEPARTMENT

Your Jackson Township Board of Trustees and Fiscal Officer have recognized and are meeting the challenge of operating with greatly reduced tax income. The Public Works Department is a combination of the Highway Department, Maintenance Department, and Park Department. This consolidation allows collaborative use of the personnel and equipment to maintain the high level of service expected by our residents.

The 200-mile Jackson Township road system is in a continuous state of wear and deterioration. We have experienced rising costs of asphalt and highway materials, gasoline, and repair costs. The Board of Trustees has carefully reviewed the daily operations for efficiency and monitored the budget for expense spending.

Jackson Township residents have continuously supported the road levy, which provides the greatly improved road and highway system that you experience today.

With the above financial challenges in mind and the ever-tightening economy, your road levy support with no new taxes has become extremely well appreciated and paramount to our continued high level of transportation service.

Retirements

The Township has recognized two new retirees from the Highway Department for their long and faithful service to Jackson Township. Stephen Ott retired August 31, 2011, after 37 years of service. Kenneth Ferguson retired September 30, 2011 after 34 years of service.

The loss of their experience and dedication will require careful and diligent replacement training effort within the Jackson Township Public Works Department.

COMMERCIAL SIGNAGE

Before installing that banner or portable sign, make sure you have obtained a sign permit from the Zoning Department to avoid costly penalty fees. A temporary sign advertising a commercial message, or products or services sold on the property is permitted to be displayed for 15 consecutive days with a permit, four times a year between January 1st and November 16th. Three additional signs are allowed with a permit between Nov. 17th and December 31st to help the advertising of specials during the holiday season.



Always check with the Zoning Department prior to displaying any outside signage.

CERTIFICATE OF COMPLIANCE

Every business in Jackson Township must register with the Zoning Department by obtaining a certificate of compliance permit, which is required prior to opening of a business in Jackson Township. Failure to obtain the certificate of compliance permit is in violation of the Jackson Township Zoning Resolution.

A new or updated certificate of compliance permit is required for the following:

- New use
- Change of ownership
- Change in tenant

Outdoor Wood-Burning Furnaces

With the winter months just around the corner, some people choose to heat their homes with outdoor wood-burning furnaces. An outdoor wood-burning furnace is defined as any equipment, device or apparatus which is installed, affixed or situated outdoors for the primary purpose of combustion of fuel to produce heat or energy used as a component of a heating system providing heat to a principal residential structure or any other site structure on the residential premises.

An outdoor wood-burning furnace may be permitted within the R-R Rural Residential District on lots that are five (5) acres or greater. An outdoor wood-burning furnace shall not be permitted within any other zoning district. All wood-burning furnaces shall meet the following requirements:

- Must be located in the rear yard only.
- Must be setback 200 ft. from all property lines.
- No outdoor wood-burning furnace shall be utilized as a waste incinerator.
- Fuels are limited to seasoned hardwood, corncobs or wood chips.
- Must comply with Stark County Building Department regulations (building, mechanical, electrical, heating) and Ohio EPA Air Pollution Control Division regulations.
- Fire Department approval of furnace location.
- Minimum stack height shall be 20 ft. from the ground at unit base.

No person shall cause, allow or maintain the use of an outdoor wood-burning furnace without a valid zoning permit.

Text Amendments

The Jackson Township Board of Trustees approved text amendments to the zoning resolution, which became effective on August 10th. Some of the text changes include revising temporary sign regulation schedules, adding definitions for internet cafes, skilled gaming rooms, and additional language for freestanding wind energy conversion systems and small structure mounted wind energy conversion systems, as well as separating recreational uses into four different classifications.
