Descriptions

<u>General Fund</u>	Includes Administration, Legal, Fiscal Office, and Zoning Departments.
<u>Park (Levy)</u>	Park employees and park expenditures.
<u>Road & Bridge</u>	Non voted taxes used for employee cost and materials necessary to maintain existing roads.
<u>Police (Levy)</u>	Voted levy tax dollars to operate the Police department.
<u>Fire/EMS (Levy)</u>	Voted levy tax dollars to operate the Fire/EMS department.
<u>Highway (Levy)</u>	Voted levy tax dollars to build new highways and improve intersections.
<u>Fire/EMS Revenue Balancing Fund</u>	Money set aside the first 3 years of a 5 year levy to help fund the last 2 years.
<u>Fire/EMS Accum Benefits Fund</u>	Money set aside for the retiring payments to Fire employees.
<u>Fire/EMS Capital Fund</u>	Money set aside for capital purchases, vehicles, building and major equipment.
<u>Police Revenue Balancing Fund</u>	Money set aside the first 3 years of a 5 year levy to help fund the last 2 years.
<u>Police Accum Benefits Fund</u>	Money set aside for the retiring payments to Police employees.
<u>Police Capital Fund</u>	Money set aside for capital purchases, vehicles, building and major equipment.
<u>Highway Accum Benefits Fund</u>	Money set aside for the retiring payments to Highway employees.
<u>Highway Capital Fund</u>	Money set aside for large highway projects.
<u>Park Revenue Balancing Fund</u>	Money set aside for the retiring payments to Police employees.
<u>Park Accum Benefits Fund</u>	Money set aside for the retiring payments to Park employees.
<u>Park Capital Fund</u>	Money set aside for capital purchases, vehicles, building and major equipment.
<u>General Revenue Balancing Fund</u>	Money set aside for future use, due to decreasing operating revenues.
<u>General Accum Benefits Fund</u>	Money set aside for the retiring payments to General fund employees.
<u>General Fund Capital (Inheritance tax used)</u>	Money set aside for capital projects in all departments.
