By signing this application, as a representative for the organization/business listed above, I agree that those listed on this application, acting on behalf of the organization/business listed, will abide by the Transient Vendor Resolution and Rules and Regulations adopted by the Jackson Township Trustees. For Commercial Transient Vendors and/or Solicitors I understand those listed on behalf of organization/business must submit to a background check completed by the Jackson Township Police Department through the Stark County Criminal Justice Information Systems (CJIS). I further understand if the criminal history check reveals a conviction for any criminal offense including, but not limited to, violent crimes, sexual assault, possession of controlled substances, theft, fraud or burglary they shall be disqualified from receiving a permit to solicit within the Township, except that if they successfully challenge the accuracy of the criminal history record information and demonstrate affirmatively by clear and convincing evidence rehabilitation has occurred, a permit may be issued provided all other regulations have been met. Transient Vendor and Solicitor Permits are valid for a period of ninety (90) days.

Badges must be worn at all times for transient vendors and solicitors.

Vendor must supply:

1. Copy of Vendors License from Auditor's office, if applicable.
2. Copy of Department of Taxation approval of tax exempt status, if applicable.
3. Copy of current food vendor license, if applicable.
4. Copy of State/Driver's license for applicant and each vendor or solicitor.
5. Documentation of vehicle type/year, license plate no. and color to be used by vendors or solicitors.
