MINUTES OF JACKSON TOWNSHIP BOARD OF TRUSTEES SPECIAL MEETING

APRIL 22, 2021

Hawke called the meeting to order at 8:00 a.m. at the Jackson Township Hall with Trustees Todd Hawke, John Pizzino, and Jim Thomas present. Fiscal Officer Gonzalez, Administrator/Law Director Vaccaro, and Fire Chief Berczik were also in attendance.

Zoning and Planning Department

Hawke moved and Pizzino seconded a motion to continue zoning amendment hearings for zoning amendment requests 643-20 and 644-20 from April 27, 2021 to a date and time to be determined by the Zoning Inspector and Township Administrator.

Peel shall pay 2% of the employee's contribution to OPFPF, and will serve a one year probationary period.
