Mr. Portyrata told the Board that Stolle Machinery has been growing and will probably be hiring another 20 to 30 precision machinists over the next 24 months. He said they have invested 3 million dollars in December on new equipment and will be investing 4 million dollars in about two weeks and probably another 4 million dollars next year. He said there has been a big shortage in the high schools. He said they generally go to R. G. Drage however they aren't drawing the type of people, education-wise, that they generally go after. He said they are considering setting up a training facility at their location. He said they are partnering with another group that will allow these young men and women get into the CNC machine industry. He said it's different than pressing a button on a machine; they are actually precision machining. He said there is a training period of about 3 or 4 years but the pay is considerable and the company also pays for a college education.

Gonzalez said that is really good news. He said it has become an issue in the labor force. He said the Trustees are finding the same problem with police and fire. He said the kids today all want to go to college and the trades and safety forces are suffering.
