The Jackson Township road levy is up for RENEWAL this November, meaning NO NEW taxes. Good leadership, dedicated workers and balanced planning has made TAXES! this possible while dealing with the rising cost of essentials like asphalt, salt and equipment. Jackson's roads are some of

the best, if not the best in Stark County. Your Highway Division prides itself in keeping the roads paved, clean and safe through all seasons and puts in the time necessary to do so.

Beyond paving, patching, salting, sweeping and plowing, the highway division provides many other services such as the replacement of curbs, catch basins, culverts and road striping. Some other projects include, the addition of new traffic signals, maintenance of the yard waste site and the major cost is keeping up with deteriorating roads. Roughly 17-19 miles of roads are resurfaced annually and that cost has risen from \$1.4 million in 2021 to nearly \$2 million this year. (See the chart below)

The highway division also does its best to keep up with requests directly from residents. Just since January of 2021 the division has taken in over 3,000 work orders from residents, and they have worked tirelessly to fulfill them. Over the past several years, the employees faced unprecedented challenges dealing with COVID resulting in time off due to illnesses and being shorthanded due to loss of staff. We are very proud of our highway workers as they met the challenges and kept up with the work.

Often our partnerships with the County, State and Federal governments create the ability for the township to obtain additional road funds by using Road Levy dollars as matching funds in combination with funding from other governmental sources. The ability to match Road Levy funds with other governmental funding sources has allowed for the completion of more local projects, and at the same time keeping the cost down for Jackson Township. A few examples of these matching funds projects are the new traffic signals at Frank and Eastlake, Strausser and Frank, Fulton and Amherst, and Perry and Jackson.

We here at the township are keenly aware of the hard earned tax dollars you provide and do our best to use them productively, wisely and efficiently in providing the best services for the least amount of money. We hope this answers any of your questions about the renewal NO NEW TAXES, and if you have any other questions or comments please feel free to call. We want you to be as informed as possible when you vote on November 8th.



#### Presidential Medal of Valor, Inspector Ryan Sprunger



On December 22, 2019, in Dalton, Ohio, Sprunger (also a member of the East Wayne Fire District) had left church and was headed home when he heard a call from his local fire station that two boys had fallen through the ice into a frozen pond. When Sprunger arrived, he found a grandfather and one child in the pond struggling to stay afloat. With a short rope and a small life vest in hand, Sprunger made it to the

just in time to see them go under the water. He jumped in, and was able to pull them out to the surface. The second child was recovered by a crew arriving at the scene. Sprunger attended to the victims until medical personnel took over.

"The brotherhood and sisterhood of firefighters are very strong," said Jackson Township Fire Chief, Tim Berczik. "Where there is a need for fellow firefighters and emergency responders, we're always going to look out for each other. That's our goal, to help our brethren, even overseas. We collected our gear that was scheduled for disposal, to protect up to 70 responders for emergency and recovery operations."

The Cleveland Maidan Association (CMA) started as a grassroots organization in 2014, aimed at providing financial aid to families of fallen or wounded veterans. Since the most recent Russian invasion, the CMA has focused their efforts on procuring medical and tactical supplies, sending critical humanitarian aid to Ukrainian hospitals and refugee camps. The CMA coordinates with partners and other nonprofits to send supplies to the front lines of the war and to those most affected. With volunteers both in the US and on the ground in Ukraine and Poland, they work to make sure that 100% of all donations and humanitarian aid is delivered to where it is most needed, quickly and effectively.

"When you have that extra support from the world and people that are hundreds and thousands of miles away, it makes a big impact," said Nadiya Petriv, a Ukrainian American who organized the donations. "They [Ukrainians] have the people and volunteers that are ready to work, so we want to make sure that as many people who are willing to help, are able to while not jeopardizing their safety as they're trying to help other people."

#### SEASONAL SAFETY MESSAGE

#### Fire Won't Wait, Plan Your Escape:

The National Fire Protection Association (NFPA) has announced "Fire Won't Wait. Plan Your Escape" as the theme for Fire Prevention Week to reinforce the critical importance of developing a home escape plan with all members of the household and practicing it regularly to ensure that everyone knows what to do when the smoke alarm sounds.



According to NFPA data, home (the place people feel safest from fire) is actually where they are at greatest risk, with 74% of all U.S. fire deaths occurring in homes. When a home fire does occur, it's more likely to be serious; people are more likely to die in a home fire today than they were in 1980.

# Following are key messages behind this year's "Fire Won't Wait. Plan Your Escape" theme:

- Make sure your home escape plan meets the needs of all your family members, including those with sensory or physical disabilities.
- Smoke alarms should be installed inside every sleeping room, outside each separate sleeping area, and on every level of your home. Smoke alarms should be interconnected so when one sounds, they all sound.
- Know at least two ways out of every room, if possible. Make sure all doors and windows open easily.
- Have an outside meeting place a safe distance from your home where everyone should meet.
- Practice your home fire drill at least twice a year with everyone in the household, including guests. Practice at least once during the day and at night.

#### Carbon Monoxide (CO) Safety:

Often called the invisible killer, carbon monoxide is an invisible, odorless, colorless gas created when fuels (such as gasoline, wood, coal, natural gas, propane, oil, and methane) burn incompletely. In the home, heating and cooking equipment that burn fuel can be sources of carbon monoxide. CO alarms should be installed in a central location outside each sleeping area and on every level of the home and in other locations where required by applicable laws, codes or standards.

- Follow the manufacturer's instructions for placement and mounting height.
- Choose a CO alarm that is listed by a qualified testing laboratory.
- Test CO alarms at least once a month; replace them according to the manufacturer's instructions.
- If the audible trouble signal sounds, check for low batteries. If the battery is low, replace it. If it still sounds, call the fire department.
- If the CO alarm sounds, immediately move to a fresh air location outdoors or by an open window or door. Make sure everyone inside the home is accounted for. Call for help from a fresh air location and stay there until emergency personnel declare that it is safe to re-enter the home.
- If you need to warm a vehicle, remove it from the garage immediately after starting it. Do not run a vehicle or other fueled engine or motor indoors, even if garage doors are open. Make sure the exhaust pipe of a running vehicle is not covered with snow.
- During and after a snowstorm, make sure vents for the dryer, furnace, stove, and fireplace are clear of snow build-up.

More than 300 kids of all ages, families and program supporters, enjoyed the 2022 Fire Truck Day presented by the Aluminum Cans for Burned Children (ACBC). Held at Portage Lakes State Park, this year's event featured trucks from 22 departments in Summit and Stark counties.

ACBC holds an annual summer camp for young burn survivors who have been treated at Akron Children's Hospital burn center. Located at the Camp Y-Noah, they enjoy fun activities while the burn center staff and ACBC board members look after their safety and medical needs. Camp activities include swimming, field trips and Fire Truck Day.

ACBC raises money to help burn survivors and their families by funding educational and

support programs, and paying for non-medical items or services that aren't covered by insurance. Aluminum can collection sites include each of the Jackson Township Fire stations.

#### FBI CLEVELAND DIVISION WARNS ABOUT INVESTMENT AND BUSINESS FRAUD SCHEMES

With today's strain on personal finances and households looking for ways to augment their income, criminals are preying on trusting eager individuals to believe in the promise of short-term financial growth and a quick return on their investment.

However, business and investment fraud criminals are ruthless; their targets are borderless and ageless, and their victims range from those living paycheck-to-paycheck to very wealthy and well-off individuals. Young adults and elderly people alike, no one is immune.

#### What is an investment or business fraud?

Investment or business fraud schemes will try to lure you in with the promise of low-or no-risk investments. Scammers often ask for cash upfront in exchange for guaranteed future returns. There is no such thing as a guaranteed return on investment. If they tell you that, be aware...it's a scam.

The FBI wants you to learn what to look out for, how to protect yourself and your family, and what to do if you are a victim.

#### What to look out for - some of the more common schemes:

- Advance fee schemes ask you to invest upfront money for a larger return later, such as a loan, contract, or gift.
- Nigerian Letter or 419 schemes ask someone to share in a percentage of millions of dollars that the author a selfproclaimed government official - is trying to transfer illegally out of Nigeria.
- Ponzi schemes use current investors' money to pay previous investors. They inevitably collapse.
- Pyramid schemes ask you to bring in new investors to make a profit or recoup your investment.
- Telemarketing fraud schemes try to steal your money over the phone, whether by telling you won a prize, are in legal trouble, or some other approach.

#### **How to Protect Yourself**

Just because someone says it is a legitimate investment doesn't always mean so. Learn how to research an investment before you transfer any money or anything of value to another person.

- Do your homework and thoroughly research any investment opportunity independently of what any salesperson provides you.
- If it sounds too good to be true, it is.
- Never rush into an investment opportunity. If you are rushed or told not to discuss it with others, you are being scammed.
- There is no such thing as a guaranteed return.

#### What to Do If You Are a Victim

Some people may be embarrassed to report they have become a victim. The FBI reminds people that by coming forward, their information may provide critical information that ultimately can lead to eliminating criminal networks. Crime reports are used for investigative and intelligence purposes. Rapid reporting can also help support the recovery of lost funds. 

**SCHOOL BUS SAFETY** 

School is back in session, and with that comes the need to use extra caution when approaching school buses that are receiving or discharging children. Whenever the roadway is divided into four or more lanes, the traffic travelling the opposite direction does not need to stop, however, the traffic travelling the same direction is required to

stop for a school bus with red flashing lights. On a road with three or less lanes, vehicles travelling in either direction are required to stop. See Ohio Revised Code 4511.75 and the below diagram for further details.



# **SNOW PARKING BAN**

With winter approaching and the snow and ice that is to be expected along with it, please keep in mind that Jackson Township does have a Snow Parking Ban (Resolution No. 14-024). The purpose of the Snow Parking Ban is to allow our Highway Division to more effectively clear snow and ice from the roads so that they are safer for travel. The Snow Parking Ban goes into effect when there is accumulation or an expectation of snow accumulation to a depth of two or more inches.

During a Snow Parking Ban, vehicles are not permitted to be parked on residential streets to allow township road crews enough room to maneuver the salt/plow trucks safely. If a vehicle is parked in violation of the Snow Parking Ban, the owner can be issued a citation with a minimum fine of \$50.00 and the vehicle may be towed from the roadway.

Please do your part to help us keep the roads clear this year by following the guidelines in this Resolution. The Snow Parking Ban Resolution 14-024 can be found on the Township web site for further information.

#### **CONSTRUCTION PROGRESS IN 2022**

As the summer construction season fades into fall, many improvements and repairs have been accomplished to the Jackson Township transportation system and resident services. Township growth along with nature and normal wear and tear demand constant attention.

Many of the contracted services we are able to accomplish are coming to an end or have been completed. These include the yearly pavement resurfacing, curbing replacement and road striping contracts.

- The 2022 resurfacing contract of \$1,984,012 is set to begin on 15.06 miles of the aging asphalt under Jackson jurisdiction, as well as one mile of repairs. Resurfacing is carefully paced and completed to assure a continuously smooth and safe roadway for all Township roads as the asphalt ages and deteriorates from weather, traffic, and assorted damages.
- Deteriorated curbing and catch basin repairs have been an ongoing effort with a public contract of \$199,111 and Highway Division labor efforts. This year 4,892 feet of curbing and many catch basins saw attention.
- Yearly striping of roadways attempt to maintain bright and visible traffic assistance. A contract was awarded during the July 12, 2022 Trustees' Meeting to JD Striping Services, Inc. for \$ 61,849.80.
- State Route 687 (Fulton Drive): This project is in its final stages and awaiting the Ohio Department of Transportation's (ODOT) approval. As part of this project, residents in this area have seen an alteration in both Yost Street NW and Armandale Avenue NW.
- Fulton Tunnel: This joint project between Stark Parks, Jackson Local Schools and the Township is moving toward completion. The contractor, Stanley Miller Construction, was able to complete the installation of the box culverts to allow for the opening of Fulton Drive prior to the first day of school on August 16. Work is continuing on both the north and south side of Fulton with items such as retaining wall installation and the movement of the sanitary line.
- Schuring Park: As the Township prepares for this project to be placed out for bid, minor work has begun. The Township was able to save money by allowing the additional dirt being removed from the Fulton Tunnel project to be placed on the park site. The engineering estimate stated that the site was going to be short +/- 15,000 cubic yards of soil. By moving the dirt to the park, this prevented us from both purchasing and hauling in of fill for the site. A big thank you to our Highway staff for assisting in this project.

#### THE DIVISIONS OF THE PUBLIC WORKS DEPARTMENT

#### **Central Maintenance**

- Our Central Maintenance Division has been working diligently on the upkeep of all our Township assets. From our vehicle maintenance staff ensuring all preventative maintenance is being completed for our Fire, Police and Highway vehicles, to our building maintenance staff ensuring all buildings are functioning each day.
- Some of the projects completed in 2022 were new roofs being placed on the Safety Center and Township Hall, and overseeing the repairs that are continuing due to the tornado that went through North Park, our Public Works Complex and Fisher Park. This included new roofs for multiple dugouts and pavilions in North, South and Fisher parks, a roof on our salt storage facility and large truck garage, and fencing and backstops in both North and Fisher Park.

#### **Highway**

- Our Highway Division continues to complete work within our roadways. From installation of new culverts under the roads, to resetting catch basins, and installation of new curbing within our allotments.
- One thing we would like to stress with our residents is the importance of keeping leaves and debris away from the storm

systems. This could be anything from catch basins to roadside ditches and drive culverts. This will prevent water from flowing during large rain events or even snow melts.

#### **Parks**

Our Park & Recreation Division has had their hands full with all the events that have taken place in our parks this past summer. From baseball and softball tournaments, to the Amphitheater shows, to the Food Truck and Farmers Market events that took place every Wednesday. As we finish up with one sporting season, the staff is adjusting for the next.



# Yard Debris Drop=Off



Our heavily used resident drop-off area in South Park on Fulton Drive has continued to be the largest in Stark County.

Jackson Township loads out this material almost daily to provide room for the vehicles and trailers that are backing up and dumping material. Kurtz Bros. provides the debris removal trucking operations. Check the website for up to date hours of the yard debris drop-off site, as they fluctuate through the year.

Fall leaves are upon us as the busiest and most crowded drop-off time of the year. We ask that residents carefully secure their loads while in transit to the drop-off site. The highway crews routinely retrieve loose debris droppings from the roadways. Also, residents are requested to back up as close as possible to the debris pile when unloading to preserve the open area for vehicle maneuvering. *Please exercise extreme caution when driving and backing in this area.* 

# SNOW BANS - Please be prepared!

Our Highway Division asks that all residents assist us with the clearing of snow and ice as the winter season nears by removing all vehicles parked on the streets during events of 2 inches or more. #### CITIZEN PORTAL For Zoning Applications

Jackson Township is now accepting zoning applications electronically by clicking on the citizen's portal link, <u>https://</u> jacksontwp.portal.iworq. net/portalhome/jacksontwp which can be found on the Zoning Department page

of our website. Utilizing the citizen's portal link to submit an application makes the process more efficient by processing permits in a timely manner, saving time, eliminating paperwork, and the applicant can avoid a trip to the zoning office. Everyone is encouraged to submit all applications electronically.

# Process for utilizing the citizen's portal to submit an application:

Go to the Zoning Department page of our website at www.jacksontwp.com.

Click on the link https://jacksontwp.portal.iworq.net/portalhome/ jacksontwp.

- Find the application that pertains to the type of permit that is required. Please make sure when applying for a permit that you put your name, address, <u>phone number and email address</u> in the applicant information field so we are able to contact you.
- Fill in all required fields as well as other fields that pertain to what you are requesting. Fields shown with an asterisk (\*) are required and must be completed in order to submit the application.
- Upload all required documents that pertain to the permit application. Required documentation depends on the type of permit you are requesting. Some examples of required documentation include but are not limited to; a site plan showing the property and any existing structures on the property, as well as the location, size and setbacks of any new structure to be built from the property lines and other structures, construction plans, house numbering slip, sewer or septic slip, Stark County Regional Planning approval letter, etc.
- Review the application to make sure it is complete and all required documentation is uploaded.
- Electronically sign the application and click the submit button.
- If the application does not submit, it is because a required field is not properly completed.
- If documents are too large to be uploaded, such as large commercial construction plans, they can be submitted to our office on a flash drive.

Once the application is submitted, it will come directly to the Zoning Department for processing. If the permit application complies with the zoning regulations, it will be processed. Once processed, our office will call or email you with the cost of the permit.

#### **BOARD OF ZONING APPEALS AND ZONING COMMISSION APPLICATIONS**

Applications to serve on the Board of Zoning Appeals and the Zoning Commission are solicited annually in the month of November. All applicants must be a resident of Jackson Township.

The Zoning Commission and Board of Zoning Appeals are comprised of five regular members that are appointed for a staggering five-year term. Two alternates may be appointed to serve a one-year term. The alternates are required to attend all meetings; however, they will only participate and vote at a hearing in the absence of a regular member. All members are required to view the property in question that is coming before the board prior to the hearing.

The Zoning Commission (ZC) considers and makes a recommendation to the Jackson Township Board of Trustees in connection with any request to rezone property (map amendment), or any request to change the zoning resolution (text amendment). Meetings are normally held on the third Thursday of the month, as needed.

The Board of Zoning Appeals (BZA) acts upon appeals from a decision or determination of the zoning inspector, considers applications for variances and the granting of conditional use permits. Meetings are normally held on the second and/or fourth Thursday of the, month as needed.

Applications are available at the Jackson Township Administration Office or on our website at <u>www.jacksontwp.com/employment-opportunities</u>. The deadline for submitting application is Friday, November 11, 2022.

#### **PAYMENT FOR PERMITS**

Zoning permits can be paid with a credit card over the phone; however, there is a credit card utilization fee of 3.25% or \$2.00, whichever is greater. Once paid, our office will email you a copy of the permit and receipt. In case of a commercial permit that was reviewed by the Fire Department, we will also email you a copy of the Fire Department letter. If you do not want to pay with a credit card, you can pay with cash or check. Checks can be mailed, or you can pay at our office. Please do not mail cash.

#### **ZONING COMPLAINTS**

Zoning complaints can also be submitted through the citizen's portal link on our website by clicking the icon on the zoning complaint form. This form is utilized for zoning complaints only. Please do not use this form for weed complaints as weed complaints are handled by a different department.

#### **NOXIOUS WEED COMPLAINTS**

All noxious weed complaints must be submitted in writing and emailed to <u>msmith@jacksontwp.com</u> or mailed to Mary Smith, Jackson Township Legal Department, 5735 Wales Avenue NW, Massillon, OH 44646. Per the weed legislation, weed complaints are only accepted April 15 through October 31.

\_\_\_\_\_ Fall Stormwater \_\_\_\_\_ MANAGEMENT PRACTICES



# As the leaves begin to change color around the Township, we are asking residents to practice good fall stormwater management practices. Here are a few tips to help you do so:

- Sweep up grass clippings and fertilizer from driveways, sidewalks and streets, and rake, mulch or compost yard waste. Don't forget to sweep along the curb. Remove leaves from your gutters, ditches and driveways, sidewalks and streets.
- Fall is the best season to fertilize your lawn and control common weeds. Weed and feed responsibly by using fertilizers and pesticides only as needed and always follow product instructions carefully. Be phosphorus conscious!
- Consider using alternative lawn-care techniques in addition to, or even instead of, pesticides. Try these: pulling weeds by hand (counts as a workout), or spot-treating weedy areas instead of your entire yard.
- Fall is a perfect time for planting trees and shrubs. Be sure to plant species native to Ohio.
- Prune your trees, shrubs, and perennials. Fall is the best time

to prune trees and other plants in your yard. Pruning allows them to jump-start their growth and utilize more stormwater.

- Clear leaves and debris from gutters. After cleaning your gutters, install a rain barrel at the end of your downspout to reduce the amount of stormwater running off of your property.
- Resist the urge to let Fido fend for himself when the weather turns colder, and keep on scooping poop. Pet waste contains phosphorus, nitrogen and harmful bacteria.
- During routine fall tune-ups, check your car and lawn equipment for leaks. A good rainstorm can send gasoline and oil drips from automobiles, lawnmowers and power equipment into waterways.
- Please try to keep your storm drains near your property clear of trash and debris. Since they flow directly into local waterways, it is important that only water enters storm drains.

# OHIO FENCE PROJECT HELPS BRING COMMUNITY TOGETHER

(This article appeared in Fencing Magazine)

When representatives of Jackson Twp, just outside of Canton, OH needed someone to install ornamental fence and screening around their new municipal amphitheater, they certainly had a contractor in mind, and they didn't have to look far. Located just 10 minutes south of the project is an almost 50 year-old, family-owned fence company. "Southway Fence has done several projects in our community" said Michael Danner who is the Park Superintendent for the township. "In fact, several members of their management team are local residents and have been aware of the project since before we broke ground." The obvious goal for the project was to come as close as possible to the vision of the design firm, SoL Harris/Day Architecture, while keeping within budget during times of rising prices and supply chain issues.

Southway's co-owner, Pete Williams Sr. contacted his supplier, Ultra Aluminum Manufacturing, and went about the process of pricing out what would turn out to be a very unique job. "I worked with Ultra's Technical Sales Representative, Chad Agacinski to put together bid numbers. We do hundreds of ornamental aluminum jobs per year, so that part was simple, however the key to the project was the louvered privacy fence that would surround the entire seating & gathering spaces of the complex. We didn't have experience with Ultra's louvered product, so Chad helped to do some value-engineering before submittals and ultimately, we were fortunate enough to be awarded the project."

Ultra Eclipse Air<sup>™</sup> is a heavy-duty horizontal louvered screening that provides both privacy and air flow. Panels are custom-made and fully welded for easy installation and are available in 4 textured powder coat colors.

Installation began in the middle of winter as did the challenges. With Southway's veteran crews, weather wasn't the issue, but rather the discovery of private utilities that were not marked by 811 services. This meant there would be constant adjustments to the fence line as well as a requirement to adjust sizes on the custom louvered panels throughout the manufacturing process. "Fortunately for us, Pete clearly communicated his needs and gave us plenty of time to make adjustments." said Agacinski. "Despite the changes, the project went very smoothly from our perspective, and we credit our customer for that"

Unlike typical ornamental fence using a "progressive" install, Eclipse Air<sup>™</sup> posts are set first, then panels are screwed onto posts using heavy-duty, stainless Tek screws. The project included everything from elevation changes requiring "stepping" of the louvered panels to a radiused section and multiple gates. "Once we dealt with the issues underground, the actual installation of the panels was very simple and went off without a hitch" said Williams Sr. "This facility is a gathering place for our entire community and I'm proud of the fact that we played a big part in its construction"




