MINUTES OF JACKSON TOWNSHIP BOARD OF TRUSTEES MEETING

APRIL 23, 2024

Hawke called the meeting to order at 3:04 p.m. at the Jackson Township Hall with Trustees Todd Hawke, Justin Hardesty, and John Pizzino present. Fiscal Officer Gonzalez, Administrator / Law Director Vaccaro, Police Chief Brink, Fire Chief Berczik, Zoning Inspector Poindexter, and Public Works Director Rohn were also in attendance.

The first order of business was a work session to discuss 7390 Braucher St., NW, also Property Maintenance Codes.

Hawke moved and Pizzino seconded a motion to go into Executive Session for Public Works Department (Highway Division) (Personnel) (Employment/Dismissal/Dismissal/Discipline)

Hawke called the General Session to order at 5:00 p.m. He requested that all cell phones be silenced at this time.

Public Speaks – Kirk Norris, Stark County Health Commissioner & Paul DePasquale, Director of Environmental Health, are here as part of their annual visits to strengthen the public image and relationships with the townships, cities, and villages in Stark County. Norris expressed that if there is ever a problem or a question to reach out to him. He will be willing to help with whatever problem the township may have.

DePasquale brought information to hand out to the trustees with contact information for him and his staff of 22 employees in the Environmental Department. This includes everything from food inspection, water wells, and septic systems. There are 14 different programs, 4 state agencies that survey those programs. He estimates that multiple staff members are in Jackson on a daily basis. Chief Berczik stated that the Fire Dept. has a good relationship with DePasquale and his staff.

Vaccaro thanked the Health Department for their assistance with a recent issue on Lake O'Springs Ave.

Requests to rezone B-1 Suburban Office & Limited Business District to R-3 Residential Planned Development District, 9.52 acres, parcel 1702617 located on the southeast corner of Dressler and Montgomery, Sect. 25SW/25SE, Jackson Twp.

Poindexter stated that this went to the Zoning Commission on March 28, 2024 and they recommend approval of rezone.

David Hayes, owner of Partner Land Company, LLC, 5060 Navarre Rd. SW, Canton, OH 44706, is proposing to develop the land to build 38 units of townhouses. There would be one egress off of Montgomery and an emergency access street off of Dressler. The open space is for a buffer zone and the drainage area. The proposed layout follows all the engineering and traffic studies.

Mike Kendall, GBC Design, Inc., 565 White Pond Dr., Akron, OH 44320, noted that there will be a private drive off of Montgomery that was approved by Stark County Engineers Office. There will also be a paved emergency assess point for the Fire Department. Storm water management basins will be placed as well as soil sediment control, which will be reviewed and approved by the Township, Stark Soil and Water, and the subdivision engineer. Some buffer landscape mounding will be placed on either side of the entrance on Montgomery.

Mark (indecipherable), K. Hovnanian Homes, 3296 Columbia Rd., Richfield, OH 44286, the townhomes would be 2 story attached townhomes with garages. This would include 3 bedroom, 2 and a half bath. They are very similar to what is being built in Green at Forest Lakes.

No one came forward in favor for the amendment.

Gary Thorley, 3976 Lindberg Ave NW, Canton, OH 44718, is representing the homeowners of Arbor Creek Allotment and is speaking against the amendment. He is a member of the HOA management board, Arbor Creek Allotment is located to the east/northeast of the proposed area. Arbor Creek is essentially a retirement community, with an estimated average age of 72. It is a quiet community. The homes sell quickly due to easy access to businesses and churches. Arbor Creek has 32 free standing homes on less than 17 acres. The request is 20% more units on less than 40% of the acreage. With 38 units and 2 cars per unit there would be 76 additional vehicles leading to noise and congestion. With the congestion, any children in the allotment will have limited space to play. Arbor Creek has a retention pond and a common area the residents of Arbor Creek do not want this area to become an unsafe play space for children. Additional traffic is undesirable for the community and is unfit. The zoning needs to remain B-1. They have no concerns with the business use of the bank that is in the area. All acreage along Dressler is B-1 and they would like it to remain B-1. They have a petition signed of 30 of the 32 homes of the Arbor Creek Allotment.

Karyn Szoka, 3990 Lindbergh Ave NW, Canton, OH 44718, is a member of the HOA board in the Arbor Creek Allotment. She is concerned about the large electrical tower. She doesn't believe people will pay top prices for these homes with this tower in their back yard.

Jordan Rosedale, 9399 Mudbrook St. NW, Massillon, OH 44646, representing Holly Dale Farms, states that their concerns are low income housing, trespassers on the property and runoff. There is a culvert that floods regularly on the land behind them. If they build more homes it is going to make the problem worse.

Donna Thorley, 3976 Lindberg Ave NW, Canton, OH 44718 stated that she worked for doctors' offices for many years and these lots were zoned for those types of businesses. Businesses close in the evenings and weekends. This area needs to stay zoned for businesses, just for the sake of traffic in the residential areas.

Francine Sheil, 3120 Miles Ave NW, Canton, OH 44718, stated that they fought to keep that area as B-1 years ago when someone wanted to change it to B-3. She also had a question as to whether the homes will be rentals or for purchase.

Gloria Callahan, 3953 Arbor Creek Ave. NW Canton, OH 44718, resides on the second property off the road. She said that the privacy of a buffer of trees is not acceptable and fencing should be considered.

David Hentsch, 3987 Lindbergh Ave NW, Canton, OH 44718, expressed his concerns over why they cannot have a road out to Dressler. With the amount of traffic that will be in and out of the allotment it will make for a difficult time. Trustee Hawke explained to him that access road is required by emergency services for two points of egress. In addition, Dressler Rd. is under the purview of Stark County Engineer's access management program and they did not allow for a full access road coming out onto Dressler. He also added that traffic lights are done by Stark County Engineers for county roads and the State of Ohio for state routes.

Luann Dimarzio, 4022 Lindbergh Ave NW, Canton, OH 44718, moved to Arbor Creek in August and loved it because it was peaceful and enjoyed the wildlife. If you develop the land you are taking the land away from the animals. Building that many townhomes will make for a lot of traffic. Walking dogs will be unsafe. She is not opposed to having something built on the lot, but 38 townhomes is too many.

David Hayes said that they designed property based off of the economics and placement of the lot. He believes that K Hovnanian builds beautiful, high quality homes.

Mark from K. Hovnanian confirmed that the homes will be for sale and not rentals. He showed what the interiors and exteriors of the homes will look like and the available options. The estimated price will is \$280,000, if not higher. There is a large buffer of trees between the four homes. He stated they are willing to possibly talk about fencing or hedges.

Trustee Pizzino asked about the electrical towers and if they have discussed with electrical companies about building there. The culverts and storm water management collection basins were also discussed. They stated that Stark County and EPA have rules and regulations that have to be followed and inspected throughout the project with the intent to preserve the water quality and handling for drainage purposes. Rohn explained how the process of installing basins and why retention ponds are important. There was additional discussion surrounding the approval of the plans through Stark County Regional Planning Commission and Stark Soil and Water.
