NOTICE OF HEARING

Dear Richard A & Ella M Horkey:

Enclosed please find a copy of a written report filed by the Jackson Township Zoning Inspector declaring that you have black trash bags, buckets and miscellaneous trash and debris on your property as defined by Ohio Revised Code 505.86 and 505.87. It is alleged the garbage, trash and debris are in violation of Ohio Revised Code sections 505.86, 505.87 and the community standard for your property within the meaning of the Township's Nuisance Legislation (attached November 15, 1989 Nuisance Legislation amended April 25, 2011).

This is to inform you that a hearing has been set before the Board of Trustees on **Tuesday, April 22, 2025, at 5:00 p.m.** for its determination of whether the questioned garbage, trash and debris are covered by Ohio Revised Code sections 505.173, 505.86, 505.87 and the Township's Nuisance legislation and constitute a nuisance and/or violation of Ohio Revised Code sections 505.86 and 505.87. The hearing will take place at the Jackson Township Administration Building, located at **5735 Wales Ave., NW, Massillon, OH 44646.**

At said hearing, the Board of Trustees will receive evidence from the Zoning Inspector concerning the above described structure, and you will be provided with the opportunity to present any evidence on your behalf.

At the conclusion of the hearing, the Board of Trustees will make a determination as to what remedy, if any, will be ordered with respect to your property.
