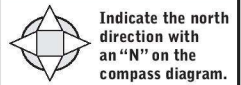
NARRATIVE

UNIT 1 WAS PARKED, UNOCCUPIED IN A MARKED PARKING SPACE FACING EAST, ON THE WEST SIDE OF THE BUILDING AT 5569 FULTON DR NW (OHIO TEA COMPANY). UNIT 2 WAS REVERSING TO THE SOUTH EAST FROM A MARKED PARKING SPACE ON THE NORTH SIDE OF JOSE'S LANDING. UNIT 2 STRUCK A LARGE ROCK WHICH BECAME DISLODGED FROM ITS FOUNDATION AFTER THE INITIAL CONTACT AND ROLLED INTO UNIT 1. UNKNOWN UNIT 2 THEN LEFT THE SCENE WITHOUT LEAVING ANY INFORMATION.

UPDATE: UNIT 2 LATER MADE CONTACT WITH POLICE AND PROVIDED ALL INFORMATION REQUIRED BY LAW.

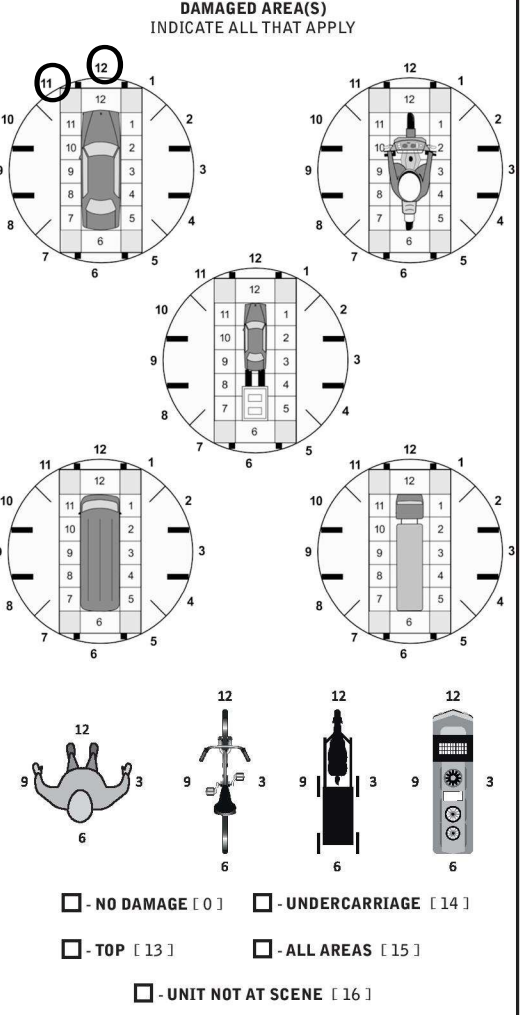
