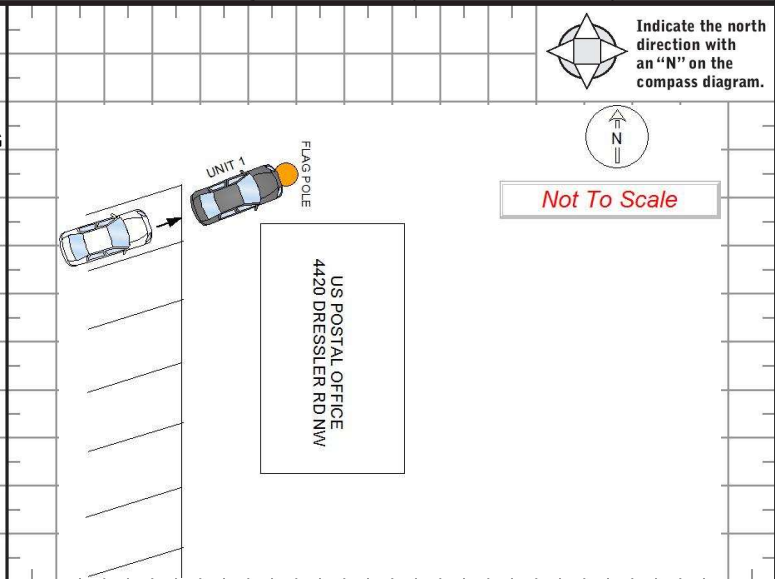

DRIVER OF UNIT 1 ADVISED THAT SHE HIT HER ACCELERATOR PEDAL INSTEAD OF HER BREAK PEDAL AND STRUCK A FLAG POLE ON THE NORTH EAST SIDE OF THE PARKING LOT, CAUSING DISABLING DAMAGE TO UNIT 1 AND PROPERTY DAMAGE AT THE ABOVE LISTED LOCATION. DRIVER OF UNIT 1 STATED THAT SHE HIT HER CHEST ON THE WHEEL DURING THE IMPACT. JACKSON TOWNSHIP EMS RESPONDED TO SCENE FOR DRIVERS INJURIES.
